

# PIMCO Diversified Income Fund

#### Multi-sector fund that aims to optimize credit exposure to maximize total returns

Investing across the global credit opportunity set, with a focus on sectors that may provide incremental yield over developed market government bonds, the fund seeks to generate returns above traditional core bond holdings.
