FUND DESCRIPTION

The PIMCO Multisector Bond Active Exchange-Traded Fund (Ticker: PYLD) is a benchmark-agnostic, multisector, actively-managed bond ETF that seeks to deliver diversified yield and long term capital appreciation consistent with prudent investment management. The Fund maintains broad exposure to a diverse array of vield-oriented fixed income sectors with emphasis on investments that are more strategic, or long-term in nature with less emphasis on short-term, tactical trading strategies. The Fund seeks to achieve its investment objective by investing under normal circumstances at least 80% of its net assets in a multisector portfolio of fixed income instruments of varying maturities including corporates (investment grade, high yield, preferred securities, bank loans), mortgages (agency, nonagency, CMBS), sovereigns (developed market, emerging market), and ABS.

Purchases and redemptions directly with ETFs are only accomplished through creation unit aggregations or "baskets" of shares. Shares of an ETF, traded on the secondary market, aré bought and sold at market price (not NAV). Brokerage commissions will reduce returns. Net Asset Value (NAV) represents an ETF's per-share value. The per-share value of an ETF is calculated by dividing the total value of the securities in its portfolio, less any liabilities, by the number of ETF shares outstanding. ETF shares are valued as of the close of regular trading on the New York Stock Exchange (normally 4:00 P.M. Eastern Time) (The "NYSE Close") on each business day. The Fund's Net Asset Value, shares outstanding and total net assets are calculated as of the close of regular trading on each day that the New York Stock Exchange is open, and do not reflect security transactions or Fund shares created or redeemed on the date stated. Such transactions are recorded on the next business day and reported on the website the following business day. Returns are average annualized total returns, except for those periods of less than one year, which are cumulative. Market returns are based upon the midpoint of the bid/ask spread at 4:00 pm Eastern time (when NAV is normally determined for most ETFs), and do not represent the returns you would receive if you traded shares at other times.

Shares of an ETF may trade on an exchange at prices at, above or below their most recent NAV. The per share NAV of an ETF is calculated at the end of each business day, and fluctuates with changes in the market value of the Fund's holdings. The trading prices of an ETFs shares fluctuate continuously throughout the trading day based on market supply and demand, which may not correlate to NAV. The trading prices of an ETFs shares may differ significantly from NAV during periods of market volatility, which may, among other factors, lead to the Fund's shares trading at a premium or discount to NAV.
