

## Change of Name Form

Use this form if you are an existing investor and wish to correct your name. Do not use this form if you wish to transfer your investment to someone else.

1. Please complete all sections in block capitals and using a black pen. If you make an error while completing this form, do not use correction fluid. Cross out your mistakes and initial your changes.

Please double check that you have completed the following:

- written your account number and account name as it appears on your latest periodic or transaction statement
- completed and signed the name change section relevant to you.

2. Collect and certify the documents needed to identify and verify the name change.

Make copies of your change of name document(s) and arrange for them to be certified.

- **Certifying copies**

You must have someone certify the copies you send to us. The following people can be the certifier:

- **your financial adviser**

so long as they are an officer with, or authorised representative of, a holder of an Australian financial services licence (or foreign equivalent), having 2 or more continuous years of service with one or more licensees, or

- **your accountant**

so long as they are a member of the Institute of Chartered Accountants in Australia, CPA Australia or the Australian National Institute of Accountants (or foreign equivalent) with 2 or more years of continuous membership, or

- **your lawyer**

so long as they are a person who is enrolled on the roll of the Supreme Court of a State or Territory, or the High Court, of Australia or foreign country, as a legal practitioner (however described), or

- **an Australian justice of the peace, notary public or a police officer**

- **or foreign equivalent, or**

- **a post office worker**

so long as they are in charge of a Post Office or are a permanent employee with 2 or more years of continuous service, or

- **a bank or financial institution officer**

so long as they are an officer with 2 or more continuous years of service with one or more financial institutions or companies, or

- **a consular officer**

so long as they are a consular officer or diplomatic officer, or

- **a judge, magistrate, chief executive officer of a court, or registrar or deputy registrar of a court, police officer or a notary public.**

### What should the person certifying write?

"I [name] of [address] being [capacity e.g. Justice of the Peace] certify this and the following [x] pages as a true copy of the original document." Each page should be initialed by the person certifying your documents.

### Not in English?

Documents not in English must be accompanied by an English translation prepared by an accredited translator (contact us if you need guidance on accredited translators).

- signed the Change of Name Form
- included the required change of name documents

### 3. Your privacy

Who needs to sign this form

**Power of Attorney** – if you have not already lodged the Power of Attorney with us, please attach a certified copy of the Power of Attorney document that includes Certificate of Witness and Statement of Acceptance and Certified Identification Document of the Power of Attorney. I/we attest that the Power of Attorney has not been rescinded or revoked and that the Donor is still living.

In consideration of amending the register you must agree to indemnify and forever keep indemnified us (including our directors, offices and employees) from and against all losses, claims, actions, proceedings, demands, costs and expenses which may be made or brought against us by reason of compliance with your request.
