

PIMCO Global Income Opportunities Fund Announces Annual Redemption

TORONTO, ONTARIO (April 3, 2023) – PIMCO Global Income Opportunities Fund (the “Fund”) (TSX: PGI.UN) announced that the redemption price for the 339,340 Class A Units (the “Units”) that have been tendered for redemption on the annual redemption date of March 31, 2023 will be \$7.33504 per Unit. Redeeming unitholders will also be entitled to receive the March monthly distribution of \$0.05688 per Unit, payable on April 14, 2023. Payment of the proceeds of redemption will be made on or before April 24, 2023.
