# 2020 Municipal Bond Fund Information

Dear FISH: Series TE Shareholder:

This letter contains additional tax-related information for shareholders of the FISH: Series TE (the "Portfolio").

We hereby affirm that 97.67% of the dividends paid by the Portfolio were "exempt-interest dividends" which are exempt from federal income tax.

Some of the federally tax-exempt interest dividends paid by the Portfolio may not be exempt from your state's income tax. Below is a breakdown of the Portfolio's tax-exempt interest income by state. The percentage of your tax-exempt interest dividends that is not derived from your state can be computed by subtracting the percentage shown for your state from 100%. For example, if you were a resident of New York, the percentage of your income dividends that is not New York income is  $100\% - 8.91\% = 91.09\%$ .
