

# PIMCO Low Duration Fund II

#### A conservative core bond investment

Focused on shorter-term securities, the fund employs a core bond strategy incorporating PIMCO's total return philosophy. It provides broad U.S. bond market exposure while maintaining a lower sensitivity to interest rate movements.

Fund classes share the same portfolio, but have different investment minimums and different fees and expenses.
