Fund description

The Diversified Income Fund is an actively managed portfolio that invests across a broad universe of fixed income instruments in the global credit markets. The investment universe spans a range of sectors, including global investment grade and high yield corporates, emerging market debt, and other global credit and spread sectors. The fund aims to maintain a high degree of diversification, an intermediate duration overall, and makes limited tactical use of currency exposures outside of the U.S. dollar.

INVESTOR BENEFITS

This fund offers investors efficient exposure to global investment grade, high yield corporate credit and emerging markets debt.

Potential benefits of this fund include:

- A single access point to the broad spectrum of global credit sectors
- A potentially higher yielding alternative to core fixed income
- A dynamic, flexible investment approach guided by PIMCO's top-down macroeconomic outlook and bottom-up credit research
- Seeks attractive risk-adjusted returns through a diversified, risk-conscious investment approach

THE FUND ADVANTAGE

The fund is an efficient way to gain exposure to a broad range of sectors in the global credit markets in a co-mingled vehicle. The fund takes a diversified approach which looks to benefit from PIMCO's macroeconomic views on credit trends, global interest rates, duration, currencies, and curve positioning. This diversified approach aims to provide the potential for consistent outperformance over the long-term through relative value trades, especially compared to approaches that focus on a single asset class.

VALUE OF CREDIT STRATEGIES

An allocation to PIMCO's credit strategies may be beneficial as part of a diversified portfolio. Corporate bonds and other credit assets tend to appreciate during periods of improving economic conditions, when government bonds may experience below average gains. Credit products should provide for the repayment of principal at maturity, and with a probable steady income stream contributing to the return, can be used as a more defensive corporate investment than equities. PIMCO credit strategies offer many options for diversification within the sector, from investment grade to high yield, in domestic, global developed and emerging markets.

ABOUT THE BENCHMARK

Benchmark 1

Bloomberg Barclays Global Credit Hedged USD contains investment grade and high yield credit securities from the Multiverse represented in US Dollars on a hedged basis. (Multiverse is the merger of two groups: the Global Aggregate and the Global High Yield).

Benchmark 2

The Fund's secondary benchmark is an equally weighted blend of the following three indices: Bloomberg Barclays Global Aggregate Credit Component ex Emerging Markets, USD Hedged; BofA Merrill Lynch Global High Yield, BB-B Rated Constrained Developed Markets Index, USD Hedged; and JPMorgan EMBI Global, USD Hedged. The Bloomberg Barclays Global Aggregate Credit Component ex Emerging Markets (USD Hedged) provides a broad-based measure of the global developed markets investment-grade fixed income markets. The BofA Merrill Lynch Global High Yield, BB-B Rated Constrained Developed Markets Index (USD Hedged) tracks the performance of below investment grade bonds of corporate issuers domiciled in developed market countries rated BB1 through B3, based on an average of Moody's, S&P and Fitch. Qualifying bonds are capitalization-weighted provided the total allocation to an individual issuer (defined by Bloomberg tickers) does not exceed 2%. Issuers that exceed the limit are reduced to 2% and the face value of each of their bonds is adjusted on a pro-rata basis. Similarly, the face value of bonds of all other issuers that fall below the 2% cap are increased on a pro-rata basis. The index is rebalanced on the last calendar day of the month. The JPMorgan EMBI Global (USD Hedged) tracks total returns for U.S. dollar-denominated debt instruments issued by emerging market sovereign and quasi-sovereign entities, Brady bonds, loans, Eurobonds and local market instruments. It is not possible to invest in an unmanaged index.
