# PIMCO 1-5 Year U.S. TIPS Index Exchange-Traded Fund

### **FUND DESCRIPTION**

The 1-5 Year U.S. TIPS Index Exchange-Traded Fund is the first exchange-traded fund (ETF) that aims to capture, before fees and expenses, the returns of the shorter maturity subset of the Treasury Inflation-Protected Securities (TIPS) market by tracking The ICE BofAML 1-5 Year US Inflation-Linked Treasury Index. The fund aims to achieve the real return (above inflation), capital preservation, and low volatility level inherent in short maturity TIPS.

## **INVESTOR BENEFITS**

Compared to a broad TIPS index (as represented by The ICE BofAML US Inflation-Linked Treasury Index), a short maturity TIPS index had less interest rate risk since the inception of The ICE BofAML 1-5 Year US TIPS Index on January 31, 2002. Potential benefits of this fund include:

- Seeks To Preserve Purchasing Power Against Inflation
   The fund seeks to help investors preserve purchasing power against inflation with low default risk by seeking real returns primarily from TIPS.
- Aims To Achieve Real Return, Capital Preservation And Low Volatility
  The fund aims to achieve the real return (above inflation), capital preservation,
  and low volatility level inherent in short maturity TIPS.
- Seeks Exposure To The Shorter Maturity Subset Of TIPS
   The fund seeks exposure to the shorter maturity subset of TIPS, which has historically had less interest rate risk, a higher correlation to inflation and lower volatility than a broad U.S. TIPS index.

If the current 30-day SEC yield is denoted with a "‡", we believe it is attributable to a rise in the inflation rate, and might not be repeated. Due to the consolidation of operations and permanence of the fund's fee waivers, such waivers do not materially affect the fund's SEC yield.
