FUND DESCRIPTION

The 25+ Year Zero Coupon U.S. Treasury Index Exchange-Traded Fund is an exchange-traded fund (ETF) that seeks to provide total return that closely corresponds, before fees and expenses, to the total return of ICE BofA Long US Treasury Principal STRIPS Index. By seeking to track the index, the fund aims to achieve the yield and duration exposure inherent in this index.

INVESTOR BENEFITS

The ETF structure allows for trading throughout the day and has the same expense ratio for all investors, regardless of size. Fund shares are publicly traded, offering accessibility to any investor who can access a major stock exchange.

Potential benefits of this fund include:

- High level of sensitivity to changes in yields, without the use of leverage
- Efficient deployment of capital by maximizing duration per dollar invested
- A liquid basket that includes only Principal STRIPS, which may trade more easily than Coupon STRIPS, potentially reducing bid-ask spreads and premium/discount to NAV
- Quarterly index and portfolio rebalancing schedule matched to quarterly dividend payments, which may reduce trading expenses
- Ability to sell short for those who believe rates will rise

With the benefit of more than 50 years of investment experience and 22 years of experience managing long duration bond portfolios, PIMCO has designed an ETF that seeks to maximize duration per dollar allocated without using financial leverage. For the capital constrained investor, higher interest rate sensitivity may be used as a tool to capitalize on expected interest rate movements or for efficient management of interest rate—sensitive liabilities.
