

PIMCO RAE PLUS Small Fund

Time-tested systematic approach to U.S. small cap value investing

By aiming to capture robust sources of excess returns and capitalizing on market inefficiencies, this strategy takes an innovative value approach to U.S. small cap equities. It is designed to outperform the Russell 2000® Value Index.

The Sharpe Ratio measures the risk-adjusted performance. The risk-free rate is subtracted from the portfolio and the result is divided by the standard deviation of the risk-free rate subtracted from the portfolio returns. P/E Ratio is a ratio of security price to earnings per share. Typically, an undervalued security is characterized by a high P/E ratio. Trailing P/E Ratio looks back at 12-month earnings per share while Forward P/E Ratio looks at earnings per share estimates for the next fiscal year. Weighted Average Market Capitalization refers to a stock market index in which larger companies (i.e. with higher market capitalization) have more influence on the indexs performance. Volatility is measured by the standard deviation, or dispersion of a set of data from its mean, based on historical portfolio returns. A larger spread of data indicates higher standard deviation and higher volatility. Morningstar ratings are only shown for those funds that have achieved a 4 or 5 star rating. Ratings for other share classes are either lower or not available. Monthly Morningstar Ratings are only shown for the INST Shares; other classes may have different performance characteristics.
