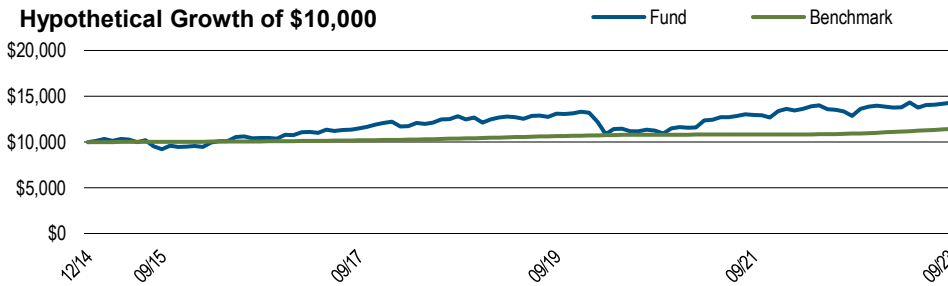


PIMCO RAE Worldwide Long/Short PLUS Fund

A word about risk: In managing the strategy's investments in **Fixed Income Instruments**, PIMCO utilizes an absolute return approach; the absolute return approach does not apply to the equity index replicating component of the strategy. **Absolute return portfolios** may not fully participate in strong positive market rallies. The **Sharpe Ratio** measures the risk-adjusted performance. The risk-free rate is subtracted from the rate of return for a portfolio and the result is divided by the standard deviation of the risk-free rate subtracted from the portfolio returns. **Volatility** is measured by the standard deviation, or dispersion of a set of data from its mean, based on historical portfolio returns. A larger spread of data indicates higher standard deviation and higher volatility.

ICE BofA SOFR Overnight Rate Index tracks the performance of a synthetic asset paying SOFR to a stated maturity.
